



Memorandum of Understanding between

Charles Darwin University (CDU)

and

Universitas Negeri Jakarta
Indonesia

Charles Darwin University in Northern Territory Australia and **Universitas Negeri Jakarta** agree to enter into a formal agreement to establish ties of mutual trust and for the mutual benefit of the two universities in promoting common interests in education and research.

Article 1 Purpose

The two universities agree to develop opportunities for academic cooperation in the following areas:

- (a) Research collaboration in areas of shared research expertise and interest;
- (b) Research training, in Masters and PhD
- (c) Workshops on preparation of academic papers and reports for academic journals
- (d) Staff exchanges for the mutual benefit of developing teaching and research collaborations for both universities;
- (e) Degree twinning programs in agreed disciplines;
- (f) Any other areas of co-operation to be mutually agreed upon by the Parties.

Nothing in this MOU shall be construed as creating any legal or financial relationship between the parties. This MOU will be construed only as an intention to foster genuine and mutually beneficial academic collaboration.

The implementation of any specific activity would form the basis of a formal agreement for specific collaborative projects or programs between the two parties.

**Article 2
Responsibilities**

2.1 Responsibilities of Charles Darwin University:

- To foster the exchange of information and staff visits and to develop practical opportunities for collaboration with Universitas Negeri Jakarta.

2.2 Responsibilities of Universitas Negeri Jakarta:

- To foster the exchange of information and to promote and develop opportunities for collaboration with CDU.

**Article 3
Confidentiality**

All exchanges of material confidential to CDU or Universitas Negeri Jakarta will be covered by separate, legally-binding confidentiality agreements.

**Article 4
Financial Arrangements**


The two parties agree that they have separate financing responsibilities and that neither party may call upon the other party for advance funding to meet advance expenditure obligations.


**Article 5
Termination**

This MOU shall cease in 3 years unless one of the parties gives written notice to the other of its intention to terminate the MOU earlier.




