



**Memorandum of Understanding
Between
State University of Jakarta and The University of Yarmouk**



Implementation of the common desire for strengthening relationship in academic and cultural cooperation between State University of Jakarta, Indonesia and Yarmouk University, Irbid, Jordan and under the Operational Program between two governments, the Republic of Indonesia and the Hashemite Kingdom of Jordan, and based on the desire to consolidate and to develop the prospects of future cooperation between the two universities, the State University of Jakarta, Indonesia and Yarmouk University, Irbid, Jordan have decided to conclude and to fulfill agreement predicated upon the following paragraphs:

Article I:

Both Universities agree to cooperate in academic program specially in Islamic sciences, Arabic Language and teaching Arabic for non native speakers.

Article II:

The two sides share scholarships for students coming to them, to continue the study for master and Ph.D degree, according to a special supplement to be agreed upon later.

Article III:

The two sides exchange their faculty members for the following purposes:

1. Short time visits, rang from (2-4) weeks to exchange experiences and acknowledgement and lecturing and seminar and evaluating team work, in accordance to the applicable laws in the two universities.
2. The send university carried the costs of travelling and the host university carried the housing and sudden disease costs, in accordance to the applicable laws in the two universities.

Article IV:

The two sides exchange documents, posters, journals, books and abstraction if Master and Ph.D, as the possibility and the desire of the two universities.

Article V:

The two sides will encourage the cooperation between the faculties in the same fields especially in the followings:

1. Exchange experiences in the field of curriculum and studying plains.
2. Operating shared researched between two sides.
3. Cooperation in holding scientific conferences between two sides.
4. Exchange experiences in the field of quality control and university management systems.

Article VI:

The two sides meet a number of academic and scientific leaders also high managers to facilitate running academic and management affairs with a number of agreed between the two sides through the official correspondences.

Article VII:

The two sides exchange teaching staff to work according to contracts if one of two sides want for one semester or more.

Article VIII:

To carry out this treaty the two sides must agree on setting program every year and detailed work plan every year as stated in the Convention.

Article IX:


The two sides work on holding other scientific and culture fields. In addition to the proceeding articles by an agreement from both sides.

Article X:

1. The present agreement shall take effect on the date of its signing by both sides and shall be valid for 4 (four) years, and renewable by both agreement in writing.
2. Any sides may terminate this agreement at any time, in a condition to notify the other side in writing before 6 (six) months at least.

This agreement signed on Irbrid Date 23 Sya'ban 1431/4 August,2010, in two original copies in Arabic and English, and in case of disagreement, English copy is reliable.
